Please insert the amended Clause 15 into the Conditions of Play for the current 20/21 EGBD Pennant season.

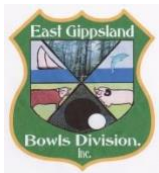

15 Interchanging of a player between sides in finals

15.1 In Weekend Pennant:

15.1.1 A Side may not include any player who during the current season has played less than **two (2)** games for the Member Club in the EGBD Pennant Competition.

15.1.2 A Side may not include any player who, during the current season has played more than **two (2)** games in any combination of higher numbered Sides unless the player has also played in **two (2)** or more games in the Side concerned and/or a lower numbered Side.

15.1.3 The provisions relating to the interchange of players between sides in finals also apply to players involved in combined sides formed under clause 6.

15.2 In Midweek Pennant:

15.2.1 A Side may not include any player who during the current season **has not** played a **game (0)** for the Member Club in the EGBD Pennant Competition.

15.2.2 A Side may not include any player who, during the current season has played a **game (1)** in any combination of higher numbered Sides unless the player has also played a **game (1)** in the Side concerned and/or a lower numbered Side.

15.2.3 The provisions relating to the interchange of players between sides in finals also apply to players involved in combined sides formed under clause 6.

15.3 A Member Club who has insufficient eligible players for any finals of an EGBD Pennant Competition may apply to the EGBD Competitions Committee for approval to play other players from the Member Club. If this approval is granted then such players may play in any position other than Skip.
